He was thereafter involved in designing, managing, monitoring and evaluating community development programmes in partnership with communities, local government officials and donor agencies, particularly with focus on poverty alleviation and economic empowerment of marginalised groups.

Abdulkareem has also built up significant experience in providing high level social policy advice to governments, and civil society institutions on programmes, projects and policies related to social sector service delivery, public sector reform, health systems development, education sector programmes and social research. He has proven facilitation skills in the application and design of participatory approaches to sustainable development; organisational development and strategic planning.

A DFID-accredited evaluation specialist, Abdulkareem has extensive experience in the use of statistical analysis packages (SPSS and SAS) and database management systems; strong analytical, logframe, writing and editing skills. In the last 18 years, he has led the development and review of M&E as well as impact assessments and shared learning systems.
