Zoë is a Principal Consultant in Itad's Inclusive Growth and Climate Change Practice. She has over ten years of expertise in international development, with specialisms in impact measurement, evaluating large and complex portfolios and multi-country evaluations, providing strategic MEL support, and qualitative methods. Zoë is the Project Director for an evaluation of a complex international policy framework to strengthen civil society on behalf of the Ministry of Foreign Affairs in the Netherlands. She recently acted as Impact Measurement and Management Specialist to advise on measuring market development approaches for FinDev Canada. She is Case Study Lead for Itad's longitudinal study of the mobilisation of private capital by BII and is advising on Itad's evaluation of BII's development impact through its Industries, Technology and Services portfolio. Zoë was the Deputy Team Leader for the evaluation of the development impact of BII's infrastructure portfolio and the Project Manager and Evaluator for Itad's evaluations of PIDG and FMO, leading on the remote case studies into investments in two countries for the FMO evaluation.

Prior to working at Itad, Zoë worked at Save the Children (STC) as their Senior Impact and Learning Advisor in their Business Programs Hub. She was the Impact & Learning Lead for the Health System Strengthening portfolio of the multi-million-pound STC-GSK partnership, developing the monitoring, evaluation, research and learning framework for the portfolio. She led several After Action Reviews to generate immediate actionable learning, including STC's Emergency Health Unit's response to Hurricane Matthew in Haiti. Zoë was the Head of Impact and Learning at Build Africa where she was the technical lead on Monitoring, Evaluation, Accountability and Learning at organisational and programmatic level. In this role, she commissioned and conducted several evaluations, including leading a Utilisation-Focused Evaluation with a project team in Uganda, working collaboratively on design, data collection, analysis and development of findings. She worked extensively on programs funded by US- and UK-based trusts and foundations, drafting annual and evaluative reports for these audiences.

Also supported the development of the overall partnership results framework and associated results dashboard, providing analysis, data interpretation and reporting against the dashboard on a regular basis to inform reporting and senior level decision-making. Identified areas of the partnership for which there were evidence gaps, designing and conducting primary research and evaluations to generate findings, recommendations and learning which could be applied directly within the partnership and more broadly across the health sector.
